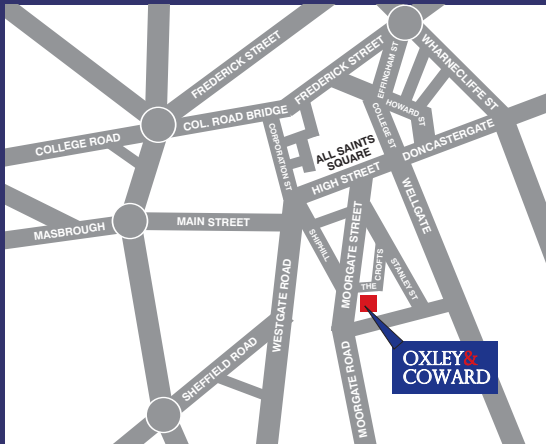
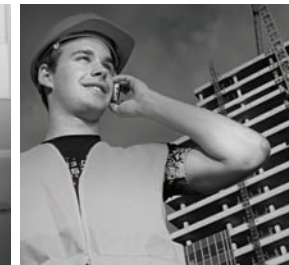

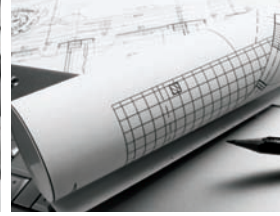


**Office Location**
